Department Highlights

December 5th and 6th Unit 1 and Unit 2 were brought to Yankee Communications to have the new Stalker DSR Radar units installed in the cruisers. This was acquired through a previously awarded grant that enabled the Division to purchase at a cost of two for one.

December 16th was the Maine Criminal Justice Academy commencement graduation ceremony for the 31st basic law enforcement training program, in Vassalboro. Deputy Lucas Libby from the Madison Division received his full-time Law Enforcement certification. Also Deputy Isaac Wacome, who is assigned to the rural division graduated as well.



The Somerset County Sheriff's Office was approved for the Distracted Driving grant through the Department of Highway Safety. Grant funds total \$15, 853, which will be distributed throughout Somerset County, to include the Madison Division. These Details will be held throughout the 2017 year.

Somerset County Court Security Deputy Joseph C. Mitchell unexpectedly passed away at his home in Madison on December 9th.

Joe retired his full- time position with Somerset County at the Madison Division in 2015, and stayed on a reserve deputy with the Department ultimately taking a position as a court security

officer at both the District and Superior courts. Previously Joe worked serving the citizens of Madison at the Madison Police Department for 35 years. We all commend Deputy Mitchell's many years of public service to his community, he will be missed by many.



December 24th, Deputy Nelson responded to a criminal mischief and theft complaint from the Elm House Laundromat on Main St. that occurred during business hours. They ripped the change machine from the wall and dragged both the change machine and the safe that was attached from the building. The investigation is ongoing, Deputy Nelson is primary investigator and will follow leads as they may develop.
